From Thursday 25 August 2011 you'll have a new and improved online account. Your new account makes it easier to check your super.

When you login you'll get a brand new look as well as:

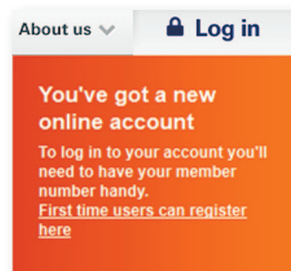
- an estimate of how many years your money will last when you retire
- access to calculators and tools that will contain your account details
- many online forms already filled in to save you time.

And if you've submitted any forms online, you'll be able to track the progress of your request.

➔ How do I log in to my new account?

From 25 August, you can register for your new online account. This is easy.

- Click log-in, then select *First time users can register here*. You'll be taken to the registration page.
- You choose your own username – you'll need your member number.
- We'll check your information and send you an email.
- Our email will include the link to activate your new account and set up your password. You choose your password.



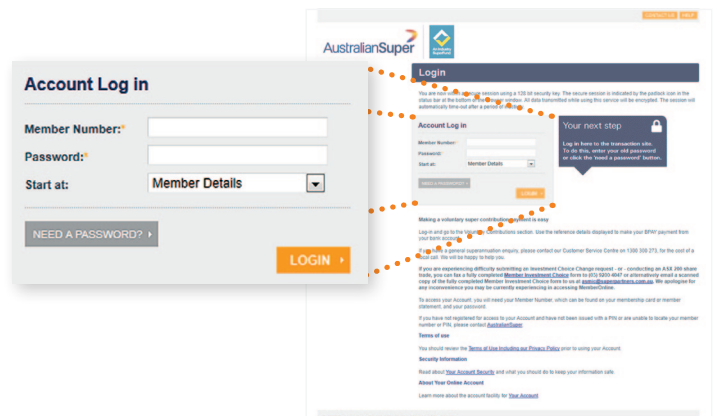
➔ You may be asked for a second password

Once you are within your new online space, you will be asked for a second password to take some actions. This will be the same password you used before we upgraded our website.

If you've forgotten this password, or you have never accessed your online account before, you can request a new password by clicking the *Need a password?* button.

The actions that require this second password:

- making an investment choice
- updating your beneficiaries
- changing the amount or frequency of your pension payments




Quick tips to accessing your new online account:

- even if you've used your online account before, you'll need to register to use your new online account. You only need your member number to do this.
- once you are in your new account, if you are asked to provide an additional password this will be the same password you used to access your online account before we upgraded our website.
